

Dear students,

with regard to the extraordinary measure of the Ministry of Health of 17 May 2021 No. 471, we would like to inform you that **with effect from 24 May 2021, the provision of accommodation on university dormitories is UNLIMITED.**

Therefore, we send you **this important information** regarding accommodation in VŠB-TUO dormitories. **Please study carefully to avoid unpleasant situations on both sides.**

I. ACCOMMODATION AT DORMITORIES IN THE ACADEMIC YEAR 2020/2021

1) In case of interest in accommodation until 23.5.2021:

Students who can not stay in the dormitories until 23.5.2021 on the basis of government regulations can use **short-term accommodation in their room at discounted prices** until this date, if they are interested in accommodation due to an exam or personal consultation. Short-term accommodation applies to students who have applied for a discount on accommodation.

Discounted prices:

- 1 night 260,- czk/person/night
- 2-3 nights 200,- czk/person/night
- Up to 7 nights 150,- czk/person/night
- over 7 nights 109,- czk/person/night

If you are interested in short-term accommodation within your room, you must check in at the AB reception, or E and pay the amount for this accommodation (in cash), see. above, **before arriving at your room**. At the reception you will receive a Statutory declaration to sign. **Otherwise, you will be charged 100% of the dormitory fee for the given month if unauthorized use of the room is detected.**

You can use the following receptions to pay for the short-term accommodation:

- reception A-B - hall A-B: students accommodated in buildings B, C and D
- reception E - ground floor of building E: students accommodated in building E

Students who have already paid the amount of short-term accommodation for the period from 24.5.2021, this amount will be returned to their account within the AT-dormitory system.

2) Accommodation from the 24.5.2021:

All students from 24.5.2021 will be charged the full amount of the dormitory fee.

II. CHECK-OUT OF THE DORMITORY

Students who want **to leave the dormitory completely** (ie hand over the vacated room and terminate their Housing contract) can do so on working days **without losing the deposit.**

CHECK-OUT OF THE DORMITORY FOR STUDENTS WHO COULD NOT BE ACCOMMODATED AT THE RESIDENCE because of government regulations:

- 1. Check-out until 23.5.2021** - the student pays a dormitory fee of 20% for the whole month of May 2021

2. **Check-out from 24.5.2021 till 31.5.2021** – the student pays the dormitory fee in the amount of 20% for the period from 1.5.2021 to 23.5.2021 and from 24.5.2021 the full price of the dormitory on the date by the check-out

Example: the student will end the accommodation on the date 26.5.2021. The price of the dormitory for the month of May 2021 is calculated as follows:

= 20% of the dormitory fees from 1.5.2021 till 23.5.2021 + daily rate of the dormitory fees x 3 days (24.5.2021-26.5.2021)

3. **Check-out within June 2021** – the student pays the full amount of the dormitory for the whole month of June 2021, regardless of the date of the check-out

For other residents, the rules for check-out of the dorm do not change.

There are two ways to check-out of the dormitory:

III. **OPENING HOURS of the Accommodation Office and Rental of beddings in MAY and JUNE 2021**

IV. **STUDENT TESTING**

Accommodation services are obliged to issue antigen tests to VŠB-TUO students who are on campus at intervals of 7 days and at the same time to check whether they have the given test. Exceptions are students who have undergone COVID-19 (and less than 90 days have passed since the first positive test) or are vaccinated. **The regulation does not apply to NON-STUDENTS.**

We would therefore like to inform you about the method of issuing tests and the next steps.

Issuing tests:

- Tests will be issued to students against signing by building managers, always on **THURSDAY and FRIDAY each week** at these times **9: 00-10: 00** and **12: 30-13: 30 hours**. If the student arrives on a day other than Thursday or Friday, he / she will pick up the first antigen test at the AB reception or E. The student will pick up the next test the following Thursday or Friday at the building manager
- Tests will need to be performed once every 7 days
- **Students accommodated in buildings B and C** have a dispensing point in building B, 2nd floor, room No. **B218** (office of the administrator, Zuzana Balážová)
- **Students accommodated in buildings D and E** have a dispensing point in building E, 2nd floor, room No. E220 (administrator's office, Ivi Alexová)

- If you are unable to attend the test for serious reasons, arrange an alternative delivery date with the building manager.

Performing tests:

- Students are required to test themselves according to the instructions given in the test.
- Students are obliged to take the test on the day when the test was provided to them and enter its result into the application without delay on the same day, see. link below (the "Application").
- In case you need help with testing, administrators will be available to guide you through the testing process.

Test result:

Students are OBLIGED to **record the result of the test in the application:**

The application must also include information that you **have undergone COVID19** (and not 90 days have passed since the first positive test) or that **you have been vaccinated**.

V. CONTROL OF IDENTIFICATION CARDS

Each time you enter the building, you must register with a student card (ISIC), which the student attaches to the card reader. The card reader is located at reception AB and reception E.

If the card issues a signal announcing that the test has not been performed, the student is obliged to duly justify this, otherwise he will not be admitted to the dormitory.

At the time of issuing Housing contracts for the year 2021/2022, those students who arrive to pick up a new Housing contract, or they are only check-out of the dormitory, don't register with the student card at the reception. They will report the reason for visiting the dormitory at the relevant reception.

VI. SHORT-TERM ACCOMMODATION FOR NO LONGER ACCOMMODATED

For those interested in short-term accommodation who are no longer accommodated in dormitories, we offer accommodation in building E.

VII. SUMMER ACCOMMODATION

Those interested in long-term accommodation in the summer months (July - August) can contact the staff of the Accommodation Office at the end of June 2021. In the case of accommodation throughout the summer holidays, a dormitory discount of CZK 10 / day will be provided. In the summer months, it is based on the basic price of accommodation (ie dynamic rates do not apply).
